I/We declare that in adopting the dog described above from Chimney Farm International Dog Rescue (CFIDR) I/We accept the following terms;

Please Initial:

- 1. To pay the adoption fee and understand it is payable upon adoption and is not refundable after adoption.
- 2. To understand that no professional behavioural assessments have been undertaken and CFIDR cannot guarantee the temperament of the dog. In relation to UK dog laws, caution must be exercised at all times and if you are in any doubt a professional dog behaviourist must be sought.
- 3. To be responsible for any dog training/behaviour and to seek behaviourist advice and/or attend training classes if required.
- 4. To take out pet insurance for your dog or have adequate resources to be responsible for any medical treatment that your dog might require in the future.
- 5. If your dog is not neutered you agree to neuter your dog once it is old enough and to inform CFIDR in writing once this has been carried out.

- 6. To allow CFIDR to visit at any point to check-up and assess the dog if needed. Should CFIDR at any time feel that the dog is in danger, or have any concerns for the dog's welfare, CFIDR have the right, with your full cooperation, to remove the dog and bring them back into its care.
- 7. If, for any reason, you can no longer care for your dog CFIDR must be informed so it can offer rescue back up and if required be returned to its care.
- 8. Excluding old age and emergencies, where CFIDR should be contacted as soon as possible, the dog must not be euthanised without prior discussion and approval from CFIDR.
- 9. To always offer your dog a safe loving home and take all necessary precautions to ensure he/she is well looked after. To feed sensibly with good nutrition to maintain a healthy weight and to exercise the dog adequately.
- 10. Not to leave the dog for prolonged periods and never to use a metal dog crate.
- 11. The microchip will be registered by Chimney Farm. You will receive notification directly from Animal Tracker. You must agree to accept the transfer and register your pet on receipt of this notification.
- 12. In accordance with the current Data Protection Law, please confirm if you are happy for us to contact you in the future?
