4. To allow CFIDR to visit at any point to check up and assess the dog if needed and should CFIDR at any time feel that the dog is in any danger or have any concerns for the dogs welfare CFIDR have the right and your full cooperation to remove the dog and bring them back into our care.

5. **IF FOR ANY REASON THE DOG CAN NO LONGER BE KEPT** CFIDR must be informed so we can offer rescue back up and if required the dog will need to be returned to our care by appointment.

9. To be responsible for the dog's training and attend training classes if/when required.

11. To have your dog neutered as soon as old enough and contact CFIDR to confirm this has been done.
